CITY COUNCIL MEETING MINUTES
AUGUST 18, 2021**

Mayor Clay McHardie called the August 18, 2021 meeting to order at 6:30 p.m.

MINUTES

Council member Brown move to approve the July 14, 2021 meeting minutes. Council member Phillips seconded the motion. Motion carried.

NEW BUSINESS

Council member Brown made a motion to hold the RNR and Budget hearing on September 8, 2021 @ 6:30 p.m. Council member Kuenzi seconded the motion. Motion carried.

Council member Brown made a motion to sponsor the Pony Rides at the Fall Festival. Council member Phillips seconded the motion. Motion carried.

Council member Brown made a motion to purchase 3 new Tasers for the police department. Council member Phillips seconded the motion. Motion carried.

Eugene asked the council if he could move forward with the gazebo for repair around \$2500.00. Council agreed to allow the Eugene to move forward.

Mayor McHardie asked the council to go into executive session for 10 minutes to discuss property acquisition. Council member Phillips made a motion to go into executive session for 10 minutes for the purpose of discussing property acquisition and would like Eugene Dick to join them. Council member Brown seconded the motion. Motion carried.
