

**CITY OF PERRY
CITY COUNCIL MEETING MINUTES
APRIL 13, 2022**

Council President Jason Phillips called the April 13, 2022 meeting to order at 6:30 p.m.

Roll was called. Members present were Issy Higgins, Felicity Ross, Derek Aldrich, Jason Phillips and Sheri Kuenzi. Mayor Clay McHardie was absent.

MINUTES

Council member Aldrich moved to approve the March 9, 2022 meeting minutes. Council member Ross seconded the motion. Motion carried.

ACCOUNTS PAYABLE

Council member Aldrich moved to approve the accounts payable. Council member Kuenzi seconded the motion. Motion carried.

NEW BUSINESS

Perry Pride will be doing a dedication of the Willkomm walking trails on June 11, 2022. Details for the dedication will be forth coming.

Wayne also asked the council to commit to donating \$6,500.00 for the fitness park.

Council member Aldrich made a motion to commit to donate \$6,500.00 to be used or rolled over or be canceled if not all funds are needed. Council member Higgins seconded the motion. Motion carried.

Eugene would like to hire Loyd Jones for part time mowing around 20 hours a week.

Council member Aldrich made a motion to hire Loyd Jones as a part time mower. Council member Ross seconded the motion. Motion carried.

Eugene also brought in some bids from Hamm's on mill and overlay. The council would like to see more than one bid so they tabled this until next month's meeting.

Eugene also informed the council that the maintiance department needs a new truck. They will need a tool bed, snowplow and new truck. The cost would be \$75,000.00.

Council member Phillips made a motion to purchase a new truck with accessories for \$75,000.00 using \$30,000.00 from ARPA funds and the remainder out of the Equipment Reserve fund. Council member Meyer seconded the motion. Motion carried.

Angie Gantz was present to discuss the Beer Garden outside of Fred's Place. The smoking outside drifts into her business. Lee will look into what was previously agreed upon with the prior people who ran Fred's.

Georgia Masten was present to inform the council that she was bitten by a dog while walking on 2nd and Poplar St. Lee informed her to turn in all of her expenses from the doctor and he will long form the complaint.

Council member Phillips made a motion to pass ordinance 823 an ordinance amending chapter XV, article 2, section 15-207 of the code of the City of Perry, Kansas updating the water service connection fee within the City of Perry, Kansas and repealing all other ordinances or portions of ordinances in conflict therewith . Council member Aldrich seconded the motion. Motion carried.
