Council member Phillips made a motion to adopt a resolution authorizing filling of application with the Kansas Department of Health and Environment for a loan under the Kansas Public Water Supply Fund Act and authorizing the mayor and city clerk to sign and submit such an application. Resolution no. 2022-07. Council member Kuenzi seconded the motion. Motion carried.

Council member Aldrich made a motion authorizing the mayor to execute the Certification Regarding Lobbying. Council member Phillips seconded the motion. Motion carried.

Council member Ross made a motion to close the Public Hearing. Council member Aldrich seconded the motion. Motion carried.
